- Step 2- Select Option 1 (Banking Services);
- Step 3- Enter your 4 digit pin;
- Step 4- Select Option 6 (Merchant Payment);
- Step 5- Select Option 1 (ZIPIT smart);

Step 7- Enter Merchant Code;

Step 8- Enter amount;

Step 9- Press 1 to confirm

A pop up message showing the Amount, Merchant Name, Merchant Code and Reference Number will appear. Press 1 to return to Main Menu or any other key to exit.

With ZIPIT Smart, individual account holders will enjoy the following benefits:

- 1. Paying a merchant directly from their mobile phone;
- 2. Making payments without using physical ATM Cards;
- 3.Reducing the costs of making payments without moving funds to mobile wallets.
